## NOMINATION CRITERIA AND INSTRUCTIONS

**COMPLETED NOMINATION FORMS ARE DUE NO LATER THAN THE FIRST MONDAY IN MAY**

The Hall of Fame awards will recognize and honor outstanding achievements of individuals, alumni, coaches, administrators, staff, and other contributors to our school. To the students and public, it will display the accomplishments of persons who have attended and been instrumental in creating an excellent tradition of Santa Cruz Valley Union High School, as well as help to strengthen the bond between the school, the community, and our alumni. Our traditions will be enhanced and others will be motivated to excellence. Honoree recognition promotes Santa Cruz as an institution worthy of continuing public support, and hopefully encourage all of us, the alumni, to continue to give & gift back and contribute to current SC students and activities.

### SC HALL OF FAME CANDIDATE CRITERIA:

- A graduate of Santa Cruz or a person who attended SC for a minimum of one year, but did not graduate for reasons other than disciplinary or academic failure
- Last day of attendance at SCVUHS must exceed ten years from the date of nomination
- Coaches, administrators, or staff who have made outstanding contributions to SC and are five years removed from service from the date of nomination; or members in our Eloy community, both living and deceased, who have made outstanding contributions to SC

**\*\*\* No member or family member of the current nominating committee will be eligible for nomination or induction into the Hall of Fame while serving on the Hall of Fame committee**

### SC HALL OF FAME CANDIDATES STANDARDS:

- High moral and ethical character, good citizenship and outstanding contribution to his or her field of endeavor; in short, he or she must be a positive role model, worthy of being emulated by current and future students
- High achievement in one or more recognized fields of cultural endeavor, such as arts, music, theater, dance, writing, etc.
- Extraordinary success in a trade, business or industry
- Distinguished service to our nation, state, or community
- Excellence in service to a recognized profession, such as law, education, medicine, journalism, and more
- Prowess in a professional or amateur sport

**\*\*\* Selection shall not be based upon sentiment or popularity, but shall consider all things such as leadership, perseverance in the face of adversity, character, and integrity**

### INFORMATION AND INSTRUCTIONS TO SUBMIT A CANDIDATE TO THE SC HALL OF FAME COMMITTEE:

- Anyone may submit a completed nomination form to the Hall of Fame committee for consideration
- Nominations may be submitted year-round, but are always due the first Monday in May for the current induction year.
- Review all eligibility and criteria items
- Inform the individual of their nomination, as well as potential award announcement and presentation dates
- Inform the nominee's representative (if one is needed), and provide this contact information on the nominee form
- Gather all information on current and past achievements to provide on the nomination form
- Have one high school digital photo and one current digital photo of nominee available by the end of May in the event the nominee is selected for induction
- All nominations will remain on file and considered for two years from the last nomination date

### HALL OF FAME AWARD AND PRESENTATION:

- The Hall of Fame Inductees will be informed by the third Thursday in July; winners will be announced to media in August
- Award presentations will be in October or November at a home SC football game
- Two awards shall be awarded to honor each inductee: One award will be presented to the inductee or their representative, the other award shall be placed on display in the Santa Cruz Valley Union High School Hall of Fame
- Any nominee or inductee found guilty of a felony shall have their Hall of Fame nominee or membership status reviewed by the Hall of Fame Committee and forwarded to the Governing Board of Education and Superintendent
- Once a person has been inducted into the SC Hall of Fame, their membership is for life
- A lifetime pass to all SC home athletic events shall be awarded to each inductee (excluding AIA playoff games)
