MONTHLY REPORTS

Business Manager's Report – Mrs. Sharon Rodriguez

Mrs. Rodriguez reported the financial audit was coming to a close with a few outstanding questions which will be addressed. Next month, Baker Tilly a.k.a Henry and Horne will be presenting their findings at the April Governing Board meeting. She went on to say, the district is concluding an ADM audit and will report on the outcome once it is finalized. Mrs. Rodriguez is starting to look at the budget revision for this year and will be listed on a future agenda.

2. Food Service Director's Report - Mr. Ricardo Cazares

Mr. Cazares reported 854 breakfast meals and 3,103 lunch meals were served for the month of February. Participants for the following meals: free 254, reduced 58 and full price 66.

A monthly expense to revenue report was submitted.

3. Facilities Director's Report - *Mr. Hector Longoria* Mr. Longoria submitted completed work orders report

4. Athletic Director's Report – Mr. Mike Ibarra

Mr. Ibarra reported winter sports officially concluded on February 27, 2023.

Student athlete placed 4th at the State Wrestling Tournament.

Santa Cruz will host a Track meet on March 29, 2023.

Replacement of baseball and softball bases including the pitcher's mound at the softball field. Spring athletic schedules have been updated and finalized as of March 6, 2023.

Mrs. Ogle complimented Mr. Ibarra for the extra help he has provided to the athletic program. Mrs. Reyes commended Mr. Ibarra for his handling of the wrestling and baseball issues and his attending games when someone else could not attend. Mr. Olveda inquired regarding what class(es) Mr. Ibarra taught. Mrs. Reyes stated freshman English for four periods and two periods are scheduled for Athletic Director.

SUPERINTENDENTS ITEMS

Mrs. Reyes announced spring break will be next week, March 13 -16, 2023. Last night was Parent/Teacher conferences and the Scarlet and Gray ceremony at which the valedictorians were announced. She went on to say, there will be four valedictorians and one salutatorian. There will be a change in the GPA requirement for the upcoming freshman class starting in the 2023-2024 school year. The current requirement base for an A, A+, or A- is the same grade point average. This will be changed so if a student receives a 98 percent this will be higher than a 92 percentage. Next school year the sophomore, juniors and seniors will not be affected by the GPA changes. They will keep the same requirements. Mr. Brown inquired if the change will start with the class of 2027. Mrs. Reyes stated "yes'.

Mrs. Reyes announced moving the Governing Board meetings to Wednesday evenings. Mr. Brown stated Wednesdays would work better with his working schedule.

Mrs. Reyes stated the academic calendar for 2023 -2024 is on the agenda. However, there will possibly be a change with the academic calendar for 2023-2024 due to an Arizona State Legislature Senate Bill SB1140, which has been approved by the Senate Elections Committee. If passed and signed by the Governor, the bill would require schools to be closed on a primary election day and general election day and require the school gymnasium be used as a polling place. It would be a requirement for teachers to be on campus and the day would count as an in-service day. Teachers would be given time to vote, but leave (absences) would not be permitted.

Mr. Olveda asked Mrs. Reyes how the school year has gone for her. She stated there have been issues but the school year has gone well. Mrs. Reyes stated enrollment has stayed at even and the 100th day has passed with enrollment numbers up. She went on to say that the Title I audit went well.
